- **Experienced** individual to performing a variety of jobs associated with the cleaning and sanitation of equipment, utensils and facility essential to the manufacturing, packaging and storage of candy products.

### ESSENTIAL DUTIES AND RESPONSIBILITIES

- Must be able to perform several varied jobs associated with the cleaning and sanitation of equipment, utensils and facility, including but not limited to: the proper use of chemicals at proper amounts, the operation and wash down of processing equipment, the use of tray washer, the use of foamier, manual cleaning of equipment and utensils, sweeping/ washing floors, washing walls and overhead pipes, etc. Perform tasks at a continual and regular speed within scheduled sanitation timeframe.
- Service, clean, or supply restrooms
- Requisition supplies or equipment needed for cleaning and maintenance duties.
  
- Clean laboratory equipment, such as glassware or metal instruments, using solvents, brushes, rags, or power cleaning equipment.
- Clean building floors by sweeping, mopping, scrubbing, or vacuuming
- Keep buildings in clean and orderly condition. Perform cleaning duties, such as cleaning floors, shampooing rugs, washing walls and glass, and removing rubbish. notifying management of need for repairs, and cleaning snow or debris from sidewalk.
- Gather and empty trash.
- Notify managers concerning the need for major repairs or additions to building operating systems.
- Follow all Company guidelines, rules, safety, FDA, and GMP policies and procedures.
- Demonstrates commitment to food safety and continuous improvement.
- Maintain a clean work area and constantly monitor equipment and facility for cleanliness issues
